Know Before You Go:

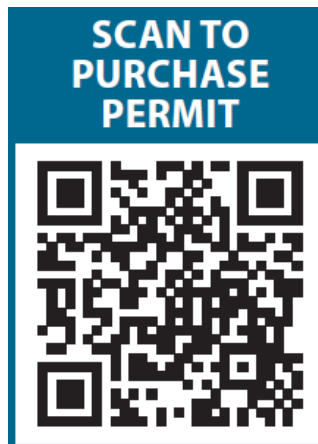
- Renters are responsible for the conduct and behavior of their group and guests and must ensure all rules and regulations are being met.
- The Scouts Canada leased space is staked and all camping units ie/ tents must be contained within the leased space. Renters can use the fire ring area as a common gathering space. The surrounding green space is public space and can be used/accessed for daytime activities by Scouts groups, Sask Parks Interpretive Programs and other park patrons.
- A valid vehicle entry permit **is required** on all vehicles while in a provincial park. Park entry fees are charged in addition to rental/lease fees. Renters and guests can purchase a vehicle entry permit using the following methods:

1. Stop at the Park Visitor Reception Centre (VRC) to purchase with Cash, Debit or Credit.

VRC Hours of Operation:

- Monday to Sunday 8am – 8pm (May Long Weekend to Sept Long Weekend)
- Monday to Friday 9am – 4pm (non-peak season)

2. Scan the QR Code to pay with Credit Card.



Note: Parents are permitted to enter and exit the park to drop off / pick up their youth providing it's within a 15-minute timeframe. During peak season parents must pick up a courtesy pass at the Park Visitor Reception Centre to avoid a fine. Off-season or after-hours parents are expected to enter and exit and adhere to the 15-minute timeframe.

- Renters are permitted to park in and around the Scouts building in an orderly fashion and must never inhibit any roadways.

- Use of Saskparks firewood is NOT permitted and is the responsibility of the renter to provide their own firewood. Please note: firewood from Elm trees is strictly prohibited.
- Saskatchewan Provincial Parks hold the right to enforce fire restrictions or fire bans at any time of your stay. Please watch Tourism Saskatchewan for the most up-to-date fire bans in the province.
- Quiet time is 24 hours a day.
- Renters are responsible for site clean-up and garbage collection. Loraas Bins are available throughout the park for garbage disposal.
- Use of tarps will be accommodated for protection from elements; tarps must not create safety concerns within renters permitted space.
 - Shelter building (for sleeping) is permitted.
 - Wind sheltering, i.e. tarps erected vertically, is not permitted.
- Use of hammocks is permitted providing Sask Parks guidelines are followed:
 - One hammock per tree.
 - Trees must be at least six inches in diameter.
 - Hammocks must be hung using nylon/polyester hammock straps (0.75 inches or wider) Rope or chain is not permitted.
 - Hammering or screwing into a tree is not permitted.
- The outdoor washroom is the responsibility of the renters to keep clean and provide all supplies.
- Park users may not remove any sign, facility, turf, rock, or the whole or part of any flower, plant, shrub, or tree.
- Wildlife is present in the park and feeding wildlife is prohibited. Keep leased area clean and all food, garbage, and attractants securely stored. Bird feeders are not permitted.
- Entrance to, attendance at, or use of a Saskatchewan Provincial Park, including the use of park equipment or facilities, carry risks of injury or loss or damage of personal property. Park users acknowledge and assume all risks, which may include lost, stolen, or damaged property, as well as personal injury to oneself or to any family members or guests. The Government of Saskatchewan and its officers, agents, and employees do not assume liability for any lost, stolen, or damaged property, or for any injury incurred while visiting Saskatchewan Provincial Parks.
